Thank you for your attendance to meet with the P.G.Reg., R.W.Bro. Watson and myself. Would you be prepared to disclose the membership of this Consortium in the interests of openness?

Having established this I thank you for your assurances and I hate to say this - there is always a But and in this case a very big <u>But</u>. I have to express my concern and indeed very great disappointment in the manner in which this was presented to the B.G.P.

The P.A.C. and Senior Officers knew nothing of this proposal until a few days before the Monday evening yet this proposal was being investigated by the Consortium some four weeks before this. I understand members of the Board and other Brethren were openly discussing this proposal over the weekend. It put my Senior Officers and P.A.C. in a most humiliating and embarrassing situation. I do not think it was promoting the ethos of F/M. <u>Due and timely warning</u>. It appears to have promoted an element of hostility and aggression amongst a certain element of the Board. Also there appears to be an opinion amongst the Board and Brethren that this presentation was orchestrated -- both very disturbing developments -- and counters my wish in promoting P.L.H. amongst the Brethren.
